



## Connection Circle Leader Agreement 2024

This Connection Circle Leader Application & Agreement 2024 (“Agreement”) is entered into between the Leader identified below and We Are Brave Together, Inc. (“WABT”) effective as of the date set forth below.

Leader and WABT agree as follows:

1. Leader will commit to lead one or more WABT support groups (“Connection Circle(s)”) for a specified timeframe in the city/state indicated above as mutually agreed upon between WABT’s Executive Director and Leader. (For example, over a 12 month period.)
2. Leader will receive support and mentoring from WABT’s Executive Director, or designated personnel.
3. WABT’s Executive Director or Lead CCL Mentor will attend at least one Connection Circle meeting (if it’s a virtual group) led by the Leader every year.
4. Facilitators will receive marketing materials from WABT, such as business cards, flyers, social media images, and expense reimbursement forms.
5. Leader to collect Connection Circle participants’ contact information (i.e. name, email, cell).
6. Leader to encourage Connection Circle participants to sign up for the WABT community via the WABT website and/or private Facebook Group.
7. After each Connection Circle meeting and upon submission of receipts, WABT will reimburse Leader for reasonable expenses of up to \$100, which includes up to \$50 for snacks and beverages and a gift card of up to \$50 to be given as a thank you to any guest presenter.
8. WABT will post each Connection Circle meeting on the WABT website for RSVP’s. WABT will forward the RSVP list of attendees to the Leader ahead of time.
9. Leader will send out a reminder email to all attendees 2-3 days in advance of the meeting.

10. Leader will conduct in-person Connection Circle Meetings; or zoom meetings, as needed. Leader will conduct Zooms for attendees who cannot attend in person. The frequency of these meetings should be monthly or every other month.

11. Leader will decide dates and times for Connection Circle meetings; and locations for meetings. Virtual meetings last one hour; in-person meetings usually last 2 to 2.5 hours in a home location. Connection circles can meet in public meeting rooms, as long as it is a private space so that attendees feel safe to share.

12. Leader is not to provide or arrange childcare for the attendees. Leader will follow such other policies and procedures as WABT may provide from time-to-time governing Support Groups.

13. In the event that the WABT Executive Director or the Leader deem it necessary to cancel the Connection Circle meetings or this Agreement, the request must be provided in writing and the WABT Executive Director and Leader will agree to meet by phone or in person to discuss.

14. Leader acknowledges that the names "WABT" and "We Are Brave Together" and associated logos are trademarks of WABT (the "WABT Trademarks"). Leader is granted the right to use the WABT Trademarks only in connection with the Connection Circles and in accordance with any instructions provided by the WABT Executive Director. Leader agrees not to use any WABT Trademarks or any similar names or marks except to the extent expressly permitted in writing by the WABT Executive Director.

15. Leader will defend, indemnify and hold harmless WABT and its officers and directors from any claims, damages, losses, liabilities, costs or expenses arising out of or related to any injury, death or damage to person or property occurring at any Connection Circle meeting hosted by Leader. This Agreement constitutes the entire agreement and supersedes all communications and no modification may be made unless in writing and signed by WABT's Executive Director and Leader. This Agreement is governed by California law and the parties consent to the personal jurisdiction and venue in the courts in California with respect to this Agreement.
